17 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,
18 hereinafter termed DFD.

20 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
21 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
22 certification applications and instructions for completing the form may be obtained from the DOA Website
23 DFD Contractor Certification page: <https://doa.wi.gov/Pages/DoingBusiness/ContractorCertification.aspx>
24 or upon request from DFD--email dfdcertification@wisconsin.gov.

26 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
27 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
28 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
29 applicable MEP division of work. These successful MEP bids must be included in all general prime
30 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
31 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
32 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
33 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
34 with the successful MEP bidders. If a project does not include any mechanical, electrical, plumbing, or fire
35 protection divisions of work, DFD will bid one bid package for all work to general prime contractors.

37 Sealed bids will be received as follows, before the time indicated above:

47 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
48 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.
49 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
50 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
51 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general, the work consists of: replacing the four hot water boilers with new energy efficient hot water
2 boilers and PLC based controls. The work will also include replacement of boiler support systems and a
3 new distribution header to the underground distribution supply and return piping.

4
5 Work shall be phased to maintain operations at all times in the facility as specified.

6
7 Electrical and controls work to support the boiler replacement project. In addition, florescent lighting
8 should be replaced with LED lighting. Lightning protection installation to protect structure based on stack
9 modifications.

10
11 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in
12 PDF format): as a downloadable file from the Division’s Projects Bidding website (see website address
13 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities
14 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding
15 information, including plan holders lists are available on the Division of Facilities Development public
16 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,
17 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify
18 the division of work they are bidding on when requesting Bidding Documents online. No deposit is
19 required to obtain documents for bidding purposes.

21 **Base Bid will be received for: A single lump sum bid for All Work.**

22
23 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

25 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD
26 Information System.

27
28 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing**
29 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**
30 **projects no longer apply. These changes take effect for projects advertised for bid after September**
31 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

32
