17 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,  
18 hereinafter termed DFD.

19  
20 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
21 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
22 certification applications and instructions for completing the form may be obtained from the DOA Website

26 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
27 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
28 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
29 applicable MEP division of work. These successful MEP bids must be included in all general prime  
30 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
31 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
32 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
33 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
34 with the successful MEP bidders.

36 Sealed bids will be received as follows, before the time indicated above:

46 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
47 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.  
48 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
49 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
50 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general, the work consists of pavement removal and replacement of the existing Private Owned Vehicle  
2 (POV) asphalt parking lot and entrance, expansion of the existing aggregate Military Vehicle Storage  
3 Compound (MVSC). Existing grades will generally be maintained except in some areas to improve  
4 drainage. Site lighting will include replacement of lights in the POV area and additional of lights in the  
5 MVSC area. Storm sewers will be included to connect the roof drain from the Readiness Center to the City  
6 storm sewer in 18<sup>th</sup> Street. Concrete work will include installation of a fuel truck pad and minor  
7 replacement of private walkways and street curbing.

8  
9 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
10 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
11 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
12 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
13 information, including plan holders lists are available on the Division of Facilities Development public  
14 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
15 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
16 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
17 required to obtain documents for bidding purposes.

19 **Base Bids will be received as a single lump sum bid for: 5) Electrical.**

20  
21 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

22  
23 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
24 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**  
25 **building projects no longer apply. These changes take effect for projects advertised for bid after**  
26 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

27  
28 A non-mandatory pre-bid tour is scheduled for January 25, 2024 at 10:00 AM at the Neillsville Readiness  
29 Center, 411 W 18<sup>th</sup> Street, Neillsville, Wisconsin. It is encouraged that contractors attend. Please contact
