20	bids on state construction projects over \$50,000. All bids received from contractors who are not certified

26	This project is being let using a new single prime bidding and contracting process. DFD will publicly
27	bid the applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work <u>first.</u> Within
28	5 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
29	applicable MEP division of work. These successful MEP bids must be included in all general prime contractor
30 31	bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will publicly open general prime contractor bids. General prime contractor bids that do not include the successful MEP
32	bids will be rejected. The state will enter into a single contract with the lowest, qualified, responsible,
33	certified general prime contractor and this general prime contractor will enter into subcontracts with the
34	successful MEP bidders.

36	Sealed bids will be received at Facilities Planning & Management, University of Wisconsin - Eau Claire,
37	651 University Drive, Eau Claire, WI 54702-4004. The bidder is responsible for the sealed bid being
38	delivered to the indicated location for receipt stamping before the time specified for the bid opening. Third
39	party delivery is entirely at the bidder's risk.

41	In general the work consists of renovation of the student residence South Hall to provide programmatic
42 43	and infrastructure upgrades that will improve functionality, efficiency, and building code compliance.
43 44	It also constructs a new accessible building entrance, expanded restrooms on each floor, and a passenger elevator.
45	passenger cievator.
46	The bathrooms on each floor will be remodeled. All room finishes will be replaced or upgraded. All
47	interior doors and door hardware will be replaced. All mechanical, electrical, and plumbing (MEP)
48	systems and associated controls; telecommunications; and security and life safey systems will be
49	replaced. All exterior windows, doors, frames and door hardware will be replaced. All roofing systems
50	will be replaced, including increasing the insulation. Exterior masonry repair, tuck-pointing, and
51	caulking will be performed on the building envelope to restore the integrity and improve energy
52	efficiency. New telecommunication rooms will be constructed. The fire alarm and smoke detection
53	system will be replaced and augmented as needed to meet current code requirements, and a new
54	automatic sprinkler system will be installed.

31	Information System.
32	Information System.
33	The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing
34	wage laws. Effective September 23, 2017, state prevailing wage requirements on state building
35	projects no longer apply. These changes take effect for projects advertised for bid after September
36	23, 2017. This change does not affect the Federal Davis Bacon Act requirements.
37	
38	A non-mandatory pre-bid tour will be held, and a pre-bid conference will be held on February 3, 2022,
39	promptly at 11:00 a.m. The scheduled Prebid tour is the only time that prospective bidders will be able to
