13 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified  
14 contractors for the above project.  
15

16 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**  
17 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes  
18 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

32 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time  
33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

34 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:

36 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

39 In general the work consists of: Replacing the existing air handling units and heat exchanger pneumatic controls  
40 with new DDC controls and a Niagara N4 Jace 8000 supervisor. This is a 2 story Department of Corrections  
41 Building with 3 inmate wings and a central core and support / common areas.  
42

43 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable  
44 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding  
45 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

53 System.

55 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**  
56 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**  
2 **affect the Federal Davis Bacon Act requirements.**

3

5 **March 14, 2023 at 10:00 AM.** The pre-bid tour is highly recommended by not mandatory.

8 Abuse and Sexual Harassment in Confinement Training Contractor Statement of Acknowledgment” forms no later  
9 than 24 hours prior to the pre-bid tour to arrange for clearance onto the institution grounds of all contractor
