18 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is
19 advertising for bids from certified contractors for the above project.

21 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**
22 **state construction projects with budgets over \$50,000.** All bids received from contractors
23 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor
24 certification applications and instructions for completing the form may be obtained from the DOA

29 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7th
30 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time
31 indicated above.

33 In general the work consists of: **removing concrete sidewalk, removing rubberized mulch,**
34 **shaping and compacting base, adding additional base aggregate as necessary, placing**
35 **concrete sidewalk, installing storm sewer structures and piping and structural slab**
36 **repairs. Additional work includes pavement marking, erosion control and site restoration.**

39 Construction bidding documents (drawings, specifications and addenda) may be obtained only
40 as downloadable electronic files (in PDF format) from the Division of Facilities Development
41 website. Construction bidding documents may also be available at various Builders' Exchanges.
42 Additional project construction bidding information, including plan holders list, is available on the
43 DFD website. Please note that a WisBuild login and password are required to download bidding
44 documents. Interested parties may request a WisBuild login and password at the DFD website
45 – allow 2 days to process login and password requests.

47 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
48 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**
49 **on state building projects no longer apply. These changes take effect for projects**
50 **advertised for bid after September 23, 2017. This change does not affect the Federal**
51 **Davis Bacon Act requirements.**
