20 advertising for bids from certified contractors for the above project.

22 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**  
23 **state construction projects with budgets over \$50,000.** All bids received from contractors  
24 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor  
25 certification applications and instructions for completing the form may be obtained from the DOA

30 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7<sup>th</sup>  
31 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time  
32 indicated above.

34 In general the work consists of: **select removal of existing walls to accommodate the**  
35 **construction of new walls for larger open office and mail room and new office. The**  
36 **construction of new spaces and reconfiguring of existing spaces will require select HVAC,**  
37 **electrical, acoustical panel ceiling and grid work.**

42 Construction bidding documents (drawings, specifications and addenda) may be obtained only  
43 as downloadable electronic files (in PDF format) from the Division of Facilities Development  
44 website. Construction bidding documents may also be available at various Builders' Exchanges.  
45 Additional project construction bidding information, including plan holders list, is available on the  
46 DFD website. Please note that a WisBuild login and password are required to download bidding  
47 documents. Interested parties may request a WisBuild login and password at the DFD website –  
48 allow 2 days to process login and password requests.

50 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
51 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**  
52 **on state building projects no longer apply. These changes take effect for projects**

1 **advertised for bid after September 23, 2017. This change does not affect the Federal**  
2 **Davis Bacon Act requirements.**
